Not illustrated.1916 Excerpt: ... bate court can only set apart the homestead of the family to the surviving constituents, and if the same be not in fact or law the homestead of the wife as well as the husband, it cannot be so set apart; but this will not have the further effect of depriving her of an allowance in lieu of the homestead, which does not in fact exist in such case, nor of the allowance in lieu of the other exemptions.⁹ And if presumptions are indulged, the same will be in favor of the existence of grounds for the separation and the allowance of her rights as widow.¹⁰ Again, only those who are lawfully married can be the surviving husband or wife contemplated by law. Therefore a putative wife, or one whose relation to the deceased was merely meretricious, would not be entitled to the exemptions or allowances.¹¹ 'not would the children of such meretricious marriage be protected.¹⁸ The writer thinks, however, the last proposition cannot be sustained in view of a statute making legitimate the issue of void marriages.¹⁸ Where the husband survives, there is no provision for setting aside the exemptions or allowances to him and the minor children, as in case of the survival of the wife.¹⁴ § 599. Abandonment and partition of homestead. The rule governing the partition of the homestead is the same where there has been an administration as where there has been none. We have already seen that no partition can be had so long as the survivor elects to occupy it, or the guardian of the minor children is permitted by order of the probate court to occupy it.¹⁶ During the life of the parent the homestead right of the child is asserted through such parent, in the absence of an order authorizing the guardian in a proper case to occupy the property as homestead, and on abandonment by the par...
